Purpose of the Anti-Kickback Laws

The statutes make it a crime for anyone to knowingly and willfully solicit or receive any remuneration (including any kickback, bribe, or rebate) in any way.

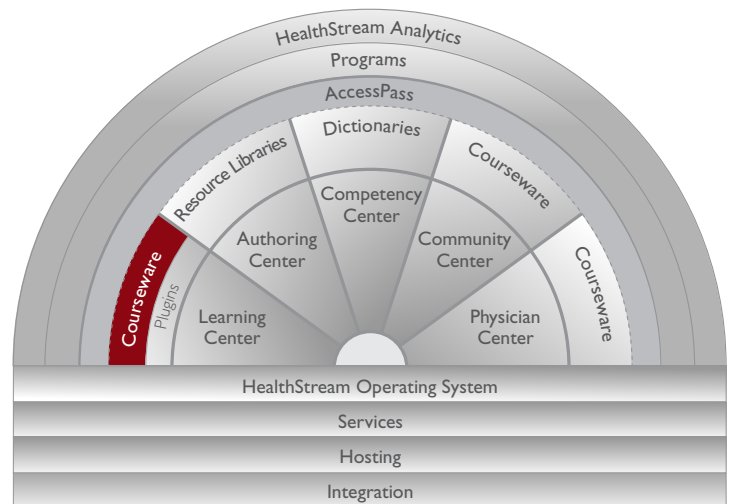
